## **MINUTES**

## **PUBLIC PARTICIPATION:**

Jason Engle addressed the board with a list of accomplishments that have taken place in East Park. As well as some suggestions of future projects to continue improvements to the East Park area.

Mike Winefeldt addressed the board concerning the Yield sign located next to his home requesting it be replaced with a Stop sign. He also voiced concern with vicious dogs in the town.

A discussion was held about replacing the Heck DO Meter used at the wastewater plant for daily testing. This has been agreed to work into the budget for the next fiscal year.

A discussion was held about the ballast needing replaced to operate the UV lights in the wastewater plant.

***Vicky Jones motioned Carla Davis seconded the motion to replace the ballast to make the UV light operational. All in favor, Motion Carried.***

A discussion was held concerning the company use of personal cell phone and if the Collector and the City Clerk to the quarterly phone reimbursement checks.

***Vicky Jones motioned Carla Davis seconded the motion to add the Collector and the City Clerk to the quarterly phone checks. All in favor, Motion Carried.***

**MISCELLANEOUS HEARINGS:**
